All work must be designed and executed by the entrant.

Accepted exhibitor/artist must be present with his/her work for duration of the Festival.

### **DISPLAY INFORMATION**

Vendor must provide & set up display on blacktop. (It may be secured with sandbags.)  
Display should have 2 sides and a backdrop. (More details sent with acceptance packet.)

### **FEEES**

A \$15 non-refundable application fee is due with application.

A \$100 per 10' by 10' booth space is due upon acceptance.

**PLEASE DO NOT SEND BOOTH FEE UNTIL YOU ARE ACCEPTED.**

### **ENTRY PROCEDURE**

- Completed Application Form with attached description of your work
- \$15.00 **non-refundable** application processing fee (make checks payable to BCAF)
- 4 good quality, close-up images of work to be sold at Festival & 1 of display booth. Images will be accepted in hard copy form, or on a CD.

Application deadline is March 14, 2014. Acceptances will be mailed the last week of March.

Late entries may be accepted, based on compliance & availability.
